**A RESOLUTION REGARDING EXTENDED TRASH PICKUP MINIMUM SIGN-UP AND CONTACT INFORMATION**

**WHEREAS**, the Town of Jarratt started offering extended trash pickup for non-residences in the surrounding areas of the town limits in 2014; and

**WHEREAS**, the extended areas include Mayes Street west of 301, Maclin Avenue, Marion Avenue, Carver Avenue, South Halifax Road north of Carver Avenue, Horseshoe road, South Allen Road east of Wyatts Mill Road, and Leeds Lane; and

**WHEREAS**, the original rules and guidelines for extended trash pickup stated reminder for payment would be given to all extended trash pickup clients; and

**WHEREAS**, the clerk is having difficulty reaching some of the extended trash pickup clients via phone; and

**WHEREAS**, the Jarratt Town Council discussed alternative methods of contacting the extended trash pickup clients during the February 6, 2023 work session; and


**WHEREAS**, the Jarratt Town Council feel the best method to contact the extended trash pickup clients will be via email.

**WHEREAS**, the Jarratt Town Council discussed a minimum signup requirement of three months.

**NOW, THEREFORE, BE IT RESOLVED THAT** the Town of Jarratt Council require:

1. All extended trash pickup clients be informed of their upcoming due date via email; and
2. All extended trash pickup clients be required to pay for a minimum of <sup>Six</sup>~~three~~ months extended trash pickup
3. This will begin July 1, 2023
4. Nothing else in the original Rules and Guidelines for Extended Trash Pickup are being changed.
