***RESOLUTION PARTNERING WITH THE GREENSVILLE COUNTY SHERIFF’S DEPARTMENT FOR (2) TWO FLOCK CAMERAS IN THE TOWN LIMITS OF JARRATT, VIRGINIA.***

**WHEREAS,** the Greenville County Sheriff’s Department has requested assistance with the purchase of (2) two additional Flock cameras to be located in the town limits; and

**WHEREAS,** the Greenville County Sheriff’s Department has jurisdiction in the Town of Jarratt; and

**WHEREAS,** the crime rate in the Town of Jarratt has increased in the past few years; and

**WHEREAS,** the Jarratt Town Council wish to assist the Greenville County Sheriff’s Department with the reduction of all types of crime in the Town of Jarratt.

**BE IT RESOLVED THAT,** the Jarratt Town Council believe it is in the best interest of the residents to have these Flock cameras installed; and

**BE IT FURTHER RESOLVED THAT,** the Jarratt Town Council agree to pay for the installation and maintenance of (2) two new Flock cameras in the town limits.

**BE IT FURTHER RESOLVED THAT,** the Jarratt Town Council authorize Mayor Wilson to sign all agreements/contracts/MOUs necessary to move this process forward.

**BE IT FURTHER RESOLVED THAT,** payments for the (2) two Flock cameras are authorized with the terms and conditions as forth in Exhibit B.

***Projected Town Costs for Flock Cameras Level of Service:***

Two (2) Flock Cameras to be installed/maintained on Grigg Avenue near the Railroad Tracks and Allen Road near the JVFD, with the initial cost of \$7,300.00 and \$6,000.00 annually thereafter.
